- 3. Jump Math Program, Carla French
  - Junior Undiscovered Math Prodigies, founded in 2002 (Dr. John Mighton)
  - evidence based program, based on "structured inquiry"
  - Aligned with Alberta's new curriculum, and is a resource used by Alberta Education
  - lessons build on foundational concepts (eg micro-progressions), builds confidence in students, laid out for students success
  - Use of this program as a complement to in class instruction, to allow for a balance between teaching and student practice
  - Each student gets an entire set of books
  - Alberta Education supports this program, however funding is not available from Alberta Education to purchase (thus this is a financial ask to our council)
  - Review is incorporated into the beginning of the year, to bring students together so that they are able to move forward as a cohesive group
  - Sandy: supported three different schools with this program, with visible improvements

        - 3. Question: School association funds all from Casino? Yes. Sometimes earn interest income too but not last year.

- 6. Chinook Park School Council Reconvened
  - Principal's Report, Guillaume Comeau & Dawn Poole
    - i. September events
    - ii. Enrollment and programming
      - 1. Student projection: 382; Current enrollment: 419
        - a. Many into kindergarten classes
        - b. Additional students into older grades (new Calgarians)

- 2. Ability to hire another teacher
- 3. No multiage classrooms, however the result is a variation in class sizes
- 4. Programming change:
  - a. Grade 6 English students receiving French as a second language (current teacher in our school!)
    - i. Supports grade 7 choice for late immersion option
- 5. Classroom readers (parent volunteers) may also be able to help with English Language Learners (ELL)
- 6. October 1st final student count
  - a. Potential for additional funds for school supports
- 7. Official Languages in Education Programs (OLEP) Federal grants
  - a. French immersion support and program retention
  - b. Funds for a program coordinator (languages)
- 8. The year ahead
  - a. Connecting with families and continuing to build culture
  - b. Continuing to attract new students, student retention, supports for all programs

  - a. Preliminary list presented here, more "asks" will come forward ahead of late October budget.
  - b. Raz Kids (October)
    - i. Accessible home reading
    - ii. Good for levelled books, to support language learners (English and French immersion)
    - iii. Estimated cost for this year US\$2.0K
    - iv. **Question**: How are book resources within the school? Would be good to have more resources on hand for home reading program.
    - v. **Question**: Is there a way to know how many people are logging in from the school? Teachers will be able to see.
    - vi. **Question**: Feedback the reading comprehension questions at the end of the book are a great resources.
    - vii. Mike Dunn: Can be funded from Association funds
  - c. Residency Fit Set Ninja
    - i. Tie into gymnastics curriculum (February)
    - ii. In three days, students would be able to go twice (30-45 minute session).
    - iii. Expect cost for 3 days to be nearly \$7K.
    - iv. Modifications are available to ensure multiple entry points for all students.
    - v. Mobile, and so will be available at school
